Dear Chairman Powell,

We are writing to express our outrage that the NEA is using taxpayer money to support objectionable and obscene movies, plays and exhibitions. The NEA received \$50 million from the American Recovery and Reinvestment Act to distribute grants to art organizations. However, much of this taxpayer money is being used to fund art projects that many Americans find offensive. The fundamental question is why is the federal government supporting artists that the taxpayers have refused to support in the open market place?


Here are a few examples of the kind of art the NEA has spent the stimulus tax dollars on:


- The NEA provided a \$50,000 grant to the Frameline film house, which recently screened *Thundercrack*, "the world's only underground kinky art porno horror film, complete with four men, three women and a gorilla."
- CounterPULSE received a \$25,000 grant to fund the weekly production of *Perverts Put Out*, a "long-running pansexual performance series" that invites guests to "join your fellow pervs for some explicit, twisted fun."
- A \$25,000 grant was given to Jess Curtis/Gravity, Inc, whose most recent works is the Symmetry Project where nude couples, including children, are mounted on each other in various poses.


Our intent is not to censor artistic freedom. Nevertheless, we are concerned that taxpayers are stuck paying for projects that are antithetical to our values and culture. These programs represent abject art. If non-profit art organizations want to sponsor these kinds of programs, then they should seek private funding and not rely on the federal government. If such private money cannot be raised, then perhaps such art has no place in our society.


